Election Procedures

AFCCA members have the right and responsibility to vote for their Board of Directors. Ballots must be filled out and returned by May 26th by mail or hand delivered no later than 5:00 pm to the Alaska Family Child Care Association, ATTN: Board Elections, 2207 E. Tudor Road, Suite 34, Anchorage, Alaska 99507. Ballots received after 5:00 pm on May 26th will not be counted in the election results. Any ballot not returned by May 26th shall be counted in the affirmative and that the member is in agreement with the Board Election Ballot. Ballots must be returned to disagree with any nominee that is on the ballot.

Each nominee shall be elected to the AFCCA Board of Directors for a term of three years. Once elected to the Board by its members on the mail-in ballot, members present shall be nominated the new Board to positions on the board for a one year term beginning June of each year. Thus enabling board members to fill another position during their three year term on the board. According to the Bylaws there seven board positions, President, Vice-President (Member-at-Large if no one desires the President's position at the end of the President's term), Secretary, Treasurer and three Members-at-Large (Four if no Vice-President).

AFCCA will hold a Board Meeting on May 26 at 7:00pm, to certify the results of the election. The secretary shall ensure all ballots are valid, shall count and record all election results. Ballots must be kept on file in case the election is contested. Each candidate shall be notified of the results of the election, if not present at the Board Meeting certifying the election. All candidates are encouraged to attend.

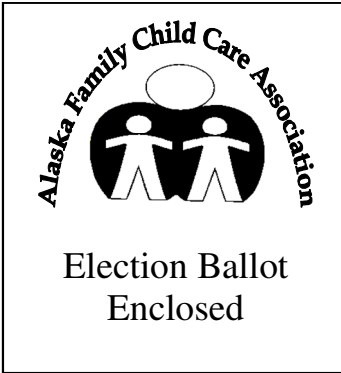
